

**RESOLUTION NO. 2021-14**

**RESOLUTION APPROVING THE MAXIMUM TAX DOLLARS FROM  
CERTAIN LEVIES FOR THE CITY'S PROPOSED  
FISCAL YEAR 2021-2022 BUDGET**

**WHEREAS**, the City Council of Fairfax, Iowa is preparing the annual budget for the Fiscal Year 2021-2022; and

**WHEREAS**, the City Council of the City of Fairfax has considered the proposed FY22 city maximum property tax dollars for the affected levy total; and

**WHEREAS**, a notice concerning the proposed city maximum property tax dollars was published and posted on the city website and social media accounts as required; and

**WHEREAS**, a public hearing concerning the city maximum property tax dollars for the affected levy total was held via a telephone conference call on February 9, 2021, at 6:00 PM from Fairfax City Hall, at 300 80<sup>th</sup> Street Court, Fairfax, Iowa.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Fairfax, Iowa, that the maximum property tax dollars for the affected tax levies for FY22 shall not exceed \$986,952, which represents more than 102% from the maximum property tax dollars requested for FY21 from the affected levies.


**BE IT FURTHER RESOLVED**, by the Fairfax City Council of the City of Fairfax, Iowa, that the Mayor and City Clerk are hereby authorized and directed to execute said resolution.

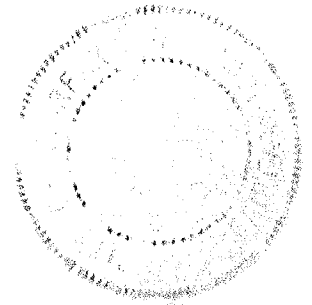
